

## NJSIAA/NJTFOA Southern Chapter Track & Field Officials

**Subject: 2017 Officiating Assignment Process & Meet Fees**

**Date: January 2017**

1. ONLY ARBITER ASSIGNMENT CALENDAR will be used – sign in on Arbiter website.
  - Select the “Blocks” tab to block out only dates you CANNOT officiate. Be sure to select “Block All Day” before clicking on dates in order to block them.
  - Select the “Profile” tab to check & update all information (address, phone number, email, etc.). OFFICIALS WHO DO NOT HAVE EMAIL, CONTACT PRIMARY ASSIGNER.
2. All official dual and championship meet assignments will be posted ONLY ON THE ARBITER WEBSITE by March 1<sup>st</sup>.
  - Officials will be responsible for a fee of \$4.00 for each accepted meet assignment.
3. Before or on the day of assignment, confirm your assignment with the host school (date, time, & location). For inclement weather day cancellations, officials MUST confirm with host school.
4. The assignor will process all officials reassignments of reschedule meets.
5. Assignments not accepted/rejected by member must be done so ASAP. A minimum of 24 hours notice before the date of schedule meet is required. Failure to notify before 24 hours, the member will be assessed a \$5.00 penalty fee per meet assigned.
6. Officiating minimum fees for 2017, as per League of Leagues contract:
  - Dual Meet Varsity (2 teams): Referee/Starter = \$63.00 ; Carded Official = \$55.00
  - Dual Meet Varsity/Sub-Varsity: \$11.00 additional for each official who officiates JV events.
  - Dual Meet Varsity (3 teams): Referee/Starter = \$72.00; Carded Official = \$63.00
  - Dual Meet Varsity (4 teams): Referee/Starter = \$95.00; Carded Official = \$82.00

- Dual Meet Varsity (5 or more teams): Referee/Started = \$105.00; Carded Official = \$91.00
- Dual Meet Scrimmage: Referee/Starter = \$58.00; Carded Official = \$50.00

Scrimmages beyond 2 hours: ADD \$10.00 per ½ hour per official.

**PLEASE NOTE:** for Middle School meet fees, substitute “# of teams” with “# of schools”.

7. If new events added to dual meets (4x100m relay &/or 4x800m relay), additional \$5.00 fee for officials working the event.
