President's Comments:

Next year we will meet at the Glenn Landing School in Gloucester Twp. The dates were displayed on the announcement board and appear at the end of these minutes.

A reminder was given that required attendance includes 2 regular and 1 mandatory meeting.

A few officials have been trading assigned positions at meets without checking with the field or track referee. This is not allowed. Keep your assignment.

The use of 9mm requires special shells and is more expensive than the 22. You can use 6mm but they can damage your gun.

There is something new on the horizon- a unified meet. More info to follow. The state sectional meets are coming up Memorial Day weekend. Allow sufficient travel time for reporting.

There is no Rules Interpretation for this month. Please note that labels on poles at times are being covered. This happens sometimes when the school makes the purchase. This is okay.

Training Activities and Q & A: A coach made a video showing how marks were being measured for throwing events by officials. There are corrections needed in officiating.

When javelin lands, mark the spot where the point hits; if the tail hits first mark the tail spot. Whatever hits the ground first is the mark you use for measuring. If it falls flat, mark where the hand grip is. Use your best judgment if you are not sure. When measuring the toe board of javelin (discus and shot) pull through measuring from inside out from landing to toe board.

When measuring shot/TJ/LJ – the measuring point is whatever is closest to the take off board- lesser $\frac{1}{4}$ in for marking. Direct the rakers to do a better job. Go to the referee if requests are made regarding the board. You can use chalk to mark the take-off board.

Red and blue hats at meets – if you are wearing a blue hat, you are not in charge. If you are wearing a red hat, you are not in charge unless you are the starter. Only one person is in charge. Refer questions to the red hat in charge.

During the high jump, the cross bar rests flat; there should be a finger's measure at end of the bar. **Foul no foul-** breaking the plane is not a foul. If you break the plane and do not touch anything –NO Foul. The plane extends to infinity. Remember wearing of a cast is illegal for high jumpers; other events you can use bubble wrap on a cast. There should be doctor's clearance for the athlete to participate.

Training ended with a few questions; the meeting was adjourned at 9:00pm.
